- 1. The Government of Bihar has applied for financing from the World Bank toward the cost of the Bihar Water Security and Irrigation Modernization Project (BWSIMP), and intends to apply part of the proceeds for consulting services.
- 2. The Mathematical Modelling Centre (MMC), established under the Water Resources Department (WRD) in Patna focuses on Flood forecasting and modelling activities across various river basins of Bihar. The objective of proposed consulting service is to review best practices of mathematical modelling related to water resources, update and improve existing models, develop drought forecasting model, flood and groundwater modelling, training and capacity building of MMC, support WRD in project planning implementation and river basin management. The duration of proposed consulting services would be time-based for 24 months duration. The duration of consultancy work can be extended as per the work interest and requirement of the client.
- 3. The Draft Terms of Reference (TOR) for the primary procurement stage for the assignment are attached to this request for expressions of interest. Please be advised that the final TOR will be provided to the shortlisted firms as part of Request for proposal (RFP).
- 4. The Director, Mathematical Modelling Centre, Patna (Water Resources Department), Govt. of Bihar now invites eligible consulting firms ("Consultants") to indicate their interest in providing the consultancy services for "Management support to Mathematical Modelling Centre (MMC) under Water Resources Department, Government of Bihar".
